The meeting of the Mayor and Board of Trustees of the Village of Phoenix, Illinois was called to Order at 7:00 p.m. by Mayor Terry Wells.

Prayer – Trustee Proctor-Harris opened the meeting with prayer.

Roll Call – Trustees Mahaffey, Proctor-Harris, Taylor, Williams. and McCullar Absent Trustee Riley

Comments by the President – The Chair motioned the approval of the lowest bid for CDBG 2107-026 by M&J Underground (7th Ave Water main Improvement Project).

Trustee Mchaffey moved the motion to approve the CDBG Project 2107-026; 2nd by Trustee Proctor-Harris; Motion passed with a unanimous roll call vote. Trustee Riley Absent

- a) Police and Fire Trustee Mahaffey indicated the Police department is looking to replace some of the cars in their fleet; she will keep the Mayor and Board of Trustees updated throughout the process. Trustee Mahaffey indicated the Fire Department needs additional supplies; a list will be submitted shortly.
- b) Public Works Trustee Proctor-Harris updated the Mayor and Board of Trustees, the out-of-service truck has been fixed and is operational. The Albert Kirkland building has been cleaned.
- c) Public Property Trustee Taylor discussed that there will be a replacement of the furnace at the MPC. There is a major clean-up project at the MPC to remove old furniture.
- d) Finance Trustee Williams noted that the next finance meeting will be on Monday, January 13th. Trustee Williams made a motion to approve the bill list; 2nd by Trustee McCullar. Motion passed with unanimous roll call vote. Trustee Riley absent.
- e) Ordinance and Resolutions The chair motioned to pass resolution \$01242023; Trustee Mahaffey moved to pass Resolution 01242023, Incumbency, Non-Litigation-Line of Credit Resolution, 2nd by Trustee McCullar. The Resolution passed with a unanimous roll call vote. Trustee Riley Absent

- b) Village Treasurer M. Ferrell –
 Treasurer Ferrell provided the board with the current state of the village's general fund account as follows. The General Ledger balance of the Village's financial status is \$692,830.09. This amount includes the balance of Property Taxes of \$341,099.10. Excluding the American Rescue Plan Act Relief Grant of (Gas Giveaway) \$240,593.53

The revenue budget for the month of January is \$210,449.00. The balance of expected revenue budgeted for the month of January is \$10,605.00





Disbursements budgeted for the month of January is \$224,155.00; the balance of disbursement budgeted for the month of January is \$17,165.00

- c) Chief Betton Total Runs 44; 2022 699 runs; Engine 241 will need to be replaced. Firefighter of the year. Food donations were made to the VA Administration.
- d) Police Sergeant Menzies Motion to hire Jesus Dominguez as Police for the Police Department was made by Trustee Mahaffey; 2nd by Trustee Proctor-Harris. Motion passed with unanimous roll call vote. Trustee Riley is absent. Motion to terminate Sharrun Harrison as a Clerk for the Police Department was made by Trustee Mahaffey; 2nd by Trustee William. Motion passed with unanimous roll call vote. Trustee Riley is absent. Sergeant Menzies shared an update on the truckload enforcement. When in court he was able to explain the law and it was understood that we are applying the law correctly.
