  Treasurer Ferrell provided the board with the current state of the village's general fund account as follows. The General Ledger balance of the Village's financial status is \$731,310.72. This amount includes the balance of Property Taxes of \$230,333.33. Excluding the American Rescue Plan Act Relief Grant of (Gas Giveaway) \$240,593.53





The revenue budget for the month of February is \$312,392.00. The balance of expected revenue budgeted for the month of February is \$8,054.00

Disbursements budgeted for the month of February is \$225,923.00; the balance of disbursement budgeted for the month of February is \$8,732.00.00
