The meeting of the Mayor and Board of Trustees of the Village of Phoenix, Illinois was called to Order at 7:00 p.m. by Mayor Terry Wells.

# Comments by the President -

There will be a gas giveaway, Sunday, April 2, 2023, from 2:00 PM to 3:00 PM There will be a fresh food giveaway, on April 20, 2023. at the MPC Trustee Proctor-Harris motioned the Board to accept the Bid from Republic Disposal as the Village's waste haulers, 2<sup>nd</sup> by Trustee Mahaffey, the motion was approved; Voted by Trustee Mahaffey, Trustee Proctor-Harris, Trustee Taylor, Trustee Williams, Trustee Riley, and Trustee McCullar.

Homewood Disposal – Mr. Frank Hillegonds: requested the Board to reconsider accepting the bid from Republic since they believed their bid was the lowest.

Trustee Proctor-Harris stated that since the bid was accepted by the Board of Trustees, they would honor the hauler's bid which was approved.

- b) Village Treasurer M. Ferrell Treasurer Ferrell provided the board with the current state of the village's general fund account as follows. The General Ledger balance of the Village's financial status is \$690,162.87. This amount includes the balance of Property Taxes of \$283,411.61. Excluding the American Rescue Plan Act Relief Grant of (Gas Giveaway) \$240,593.53

The revenue budget for the month of March is \$113,127.00. All revenue budgeted for the month of March has been received.





Disbursements budgeted for the month of March is \$250,896.00; the balance of disbursement budgeted for the month of March is \$44,855.00

- c) Chief Betton Runs YTD 152. The Fire Department is looking to hire 5 additional employees
- d) Chief Wells The motion to accept the resignation of Justin Pratt from the Police Department was motioned by Trustee Mahaffey; 2<sup>nd</sup> by Trustee McCullar. Motion passed Trustee Mahaffeky, Trustees Proctor-Harris, Trustee Taylor, Trustee Williams, Trustee Riley, and Trustee McCullar: Chief Wells Advised the Board that the department had a team meeting on March 25, 2023; and they will be having an Active Shooter's training on April 3<sup>rd</sup> and 4<sup>th</sup> at Coolidge Middle School

Three officers will be graduating from the Academy on May 6th and three additional officers will be entering the program when it resumes.

MPS Officer was removed due to budget constraints; however, the VOP Officers are patrolling the building periodically.

Citizen Participation – Mr. Ernie Lopez from Republic wants to thank the Village for the opportunity to become our new waste hauler; he is excited about the partnership.

New Business – Trustee Riley – There will be an Easter Egg hunt at Wells Park on Saturday, April 8, 2023. The community is invited to attend.
