The General Ledger balance of the Village's financial status is \$686,899.92. This amount includes the balance of Property Taxes of \$291,030.39. Excluding the American Rescue Plan Act Relief Grant of (Gas Giveaway) \$233,982.91

The revenue budget for the month of May is \$244,351.00. The balance of expected Revenue budgeted for the month of May is \$198,072.00

Disbursements budgeted for the month of May is \$265,597.00; the balance of disbursement budgeted for the month of May is \$195,991.00
