The meeting of the Mayor and Board of Trustees of the Village of Phoenix, Illinois, was called to Order at 7:00 p.m. by Mayor Terry Wells.

Prayer - Trustee Proctor-Harris opened the meeting with prayer.

# Comments by Mayor Terry Wells-

Mayor Wells moved the motioned to pay the bills, motioned by Trustee Mahaffey, 2<sup>nd</sup> by Trustee McCullar– Motion approved: Passed by Trustee Mahaffey, Trustee Proctor-Harris; Trustee Taylor, and Trustee McCullar.

- a) Police and Fire Trustee Mahaffey Deputy Chief Wells, and Sergent Schwenkel are present and will come with their reports later in the meeting—no report for this session.
- b) Public Works Trustee Proctor- Harris Public Works are cleaning alleys and maintaining the Village. Updated on the 155th Street project. The construction work will start once the rain stops. D. Anderson will be working throughout the Village, patching streets.

  The Village was awarded \$300,000 CDBG Work to start next week.
- c) Public Property Trustee Taylor MPSC is busy with events. The IML event was informative, and Trustee Taylor expressed she was glad to attend.

- f) Water Department Trustee McCullar –Water Report for the period September 1, 2023 September 25, 2023, Water \$48,435.09; Garbage \$16,081.50; Late fees \$6,196.31: Grand Total \$70,712.90

## **Department Reports**

- a) Village Administrator Administrator Cooper- If you need a commission card, see Mr. Cooper. Working on the newsletter. Trustee Mahaffey and Mr. Cooper are working with Cook County to obtain information for flood victims. The questionnaire will be available on the Website for impacted residents. FEMA accepts applications from July 2, 2023, until October 16, 2023. We are currently gathering information for the September 17, 2023, storm; once this disaster is accepted by FEMA, we will be prepared to share the resident's information.
  - CHARM recycling event will be on October 7, 2023; you will receive information regarding containers to be placed in the village; more information will come at a later date.
- b) Village Treasurer M. Ferrell Treasurer Ferrell provided the board with the current state of the village's general fund account as follows. The General Ledger balance of the Village's financial





status is \$501,813.39. This amount includes the balance of Property Taxes of \$59,635.68, Excluding the American Rescue Plan Act Relief Grant of \$24,542.91.

The revenue budget for the month of September is \$409,858.00. The balance of expected Revenue budgeted for the month of September is \$6.528.00

Disbursement budgeted for the month of September is \$240,032.00; the balance of disbursement budgeted for the month of September is \$20,188.00

Audit: The 2022 audit is ongoing

- c) Sergent Schwenkel Runs Year-to-date 484, excepting the year-end runs to be approximately 600. The Fire Department hired two new employees: Trustee Mahaffey motioned the Board to hire Abony Turnipseed and Niall Coleman, 2<sup>nd</sup> by Trustee Proctor-Harris – Motion approved: Passed by Trustee Mahaffey, Trustee Proctor-Harris; Trustee Taylor, and Trustee McCullar.
- d) Chief Wells Report 15 incidents with 1 arrest; P-Series 23; F- Series 4 with one arrest. Vincent Bonanno retired from the Police Department. National Child Identification program, the police department has the applications. They will be available at coming events. Safety Act: 4 staff members of the Police Department will be trained. Received \$25K Jag Grant. Applied for grants to purchase dash cam, tasers, and drome.

#### Citizen Participation -

Arlene Brown – 15211 8th Ave: Concern – Thank the Police Department for doing a Fantastic job. Is Phoenix a flood zone – No, it is not. Do you need a permit to put up a fence? Existing fence (replacing an old fence): no; new fence, yes, you need a permit.

Jocelyn Rial 15205 8th Ave - Concern - Noise due to a party - Chief Wells advised the resident to call the Police; The police will handle the issue.

Annie Anderson – 15241 8th Ave: Concern – water backflowing into her yard. Want to know if the Village can fix this problem. Since the issue is on private property, it's the homeowner's responsibility. Some officers are not Friendly. Tickets/tow on a car in the yard: A state law allows tickets to be written on vehicles on private property if they do not have current registration and stickers.

Shirley Williams 651 E 151<sup>st</sup> PL – Senior Building – Introduced her son (John Wade III), who has accomplished a lot. He would like to share his knowledge with the village to give them information to help them obtain solar panels (he works for Blue Raven Solar).
