The meeting of the Mayor and Board of Trustees of the Village of Phoenix, Illinois, was called to Order at 7:06 p.m. by Clerk Harris.

#### **CLERKS REPORT**

The Clerk's cash received report for the period from July 8, 2025, to August 11, 2025, is as follows: General Administration, \$251,483.99; Motor Fuel tax Collections \$12,907.63; Multi-Purpose, \$6,095.00; Grand Total, \$270,486.62.

- Village Treasurer- Treasure Ferrell Village Treasurer- Treasure Ferrell gave the following information:

The General Ledger balance of \$321,097.53 includes the balance of the Property Taxes of \$1,148.28 and the Motor Fuel tax fund of \$128,095.00.

The revenue budgeted for August is \$395,966.00; Revenue budgeted for the month of August \$229,808.00.00

The disbursements budgeted for August are \$426,850.00, and the balance for the month of August is \$346,382.00.

The monthly finance meeting was held on Monday, August 11, 2025. There were no changes to the budget.

Treasurer Ferrell requested approval to transfer \$40,000 from the Water Fund to the General Administration:

Pro-Temp Mayor Trustee Mahaffey motioned for the Board to approve the transfer of \$40,000. Moved by Trustee Proctor-Harris, seconded by Trustee Riley, the motion passed with Trustee Mahaffey, Trustee Proctor-Harris, Trustee Riley, Trustee McCullar, and Trustee Evans.

Treasurer Ferrell requested approval to transfer \$20,000 from the Multi-Purpose Fund to the General Administration:

Pro-Temp Mayor Trustee Mahaffey motioned for the Board to approve the transfer of \$20,000. Moved by Trustee Mahaffey, seconded by Trustee Proctor-Harris, the motion passed with Trustee Mahaffey, Trustee Proctor-Harris, Trustee Riley, Trustee McCullar, and Trustee Evans.

Treasurer Ferrell asked all elected officials to let her know if they want to attend the IML meeting; she would purchase the tickets on behalf of the Village.

- Chief Betton –Runs YTD 343: Commented, the front of the building looks good, great paint job.
- Chief Wells absent Comdr. Warfield was in attendance.
