ORDINANCE NO. __01092024C

AN ORDINANCE AMENDING CHAPTER 94, ARTICLE II, DIVISON II, SECTION 94-23 CODE OF THE VILLAGE OF PHOENIX, COOK COUNTY, ILLINOIS "RATES FOR WATER USED"

WHEREAS, the Village of Phoenix is a home rule municipality; and

WHEREAS, pursuant to its home rule authority, the Village of Phoenix may exercise any power and perform any function pertaining to its government and affairs;

WHEREAS, The Villages wishes to amend its water rates.

NOW, THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Phoenix, County of Cook, State of Illinois, a home rule unit Government, as follows:

SECTION 1: That Chapter 94, Article II, Division II," Section 94-23 "Rates for Water Used" of the code of the Village of Phoenix is hereby amended and shall read as follows:

94-23 Rates for Water Used:

(a) All water being supplied by the Village to residential customers shall be charged the following rate for each billing period for each 1.000 Gallons of water consumption or fraction thereof, at the rate established as follows:

Effective February 1, 2024 the rate shall be thirty-nine dollars and twenty-two cents (\$39.22) for the first two thousand (2,000) Gallons plus sixteen dollars and sixty three cents (\$16.63) for each additional one thousand (1,000) Gallons or fraction thereof, plus any increases charged by the supplier of water to the Village.

(b) All water being supplied by the Village to commercial customers shall be charged the following rate for each billing period for each 1.000 Gallons of water consumption

or fraction thereof, at the rate established as follows:

Effective February 1, 2024 the rate shall be forty dollars and thirty-nine cents (\$40.39) for the first two thousand (2,000) Gallons plus seventeen dollars and thirteen cents (\$17.13) for each additional one thousand (1,000) Gallons or fraction thereof, plus any increases charged by the supplier of water to the Village.

(c) Beginning in May of 2025, the rates in (a) and (b) shall increase by 5%, plus any supplier increase and on each May thereafter.

SECTION 2: Severability: If any provision of this Ordinance, or the application of any provision of this ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance, or their application, that can be given effect without the unconstitutional or invalid provision or its application. Each unconstitutional or invalid provision, or application of such provision, is severable, unless otherwise provided by this Ordinance.

SECTION 3: Effective Date: This Ordinance shall be effective on Lour and L., 2024, after its passage, approval and proper publication as required by law.
